

EQUITY SCHOLARSHIP FOR MAORI

Terms of Reference

Aim: To support those students who identify as Maori studying at Nelson Marlborough Institute of Technology. Priority should be given to students who are not entitled to Student Allowance or Training Incentive Allowance.

Area of Use: Students enrolled at Nelson Marlborough Institute of Technology in 2012 to start or continue a course leading to a recognised qualification.

Eligibility: Students identify themselves upon enrolment as being Maori Students and must be enrolled on a full time programme and have met specific programme entry requirements.

Exclusions: This Scholarship may not be used in conjunction with the Half Degree for Free Scholarship. These Scholarships are not available for NMIT short courses and Employment Scholarship Programmes (unless stipulated). Only one NMIT Scholarship can be awarded to a student in any one Calendar Year.

Value & Funding: Maximum allocation of \$500. This Scholarship is funded by NMIT. And payment will be by means of rebate on fees or to studylink if a debt exists.

Promotion: Application forms and information will be circulated via student enrolments, and advertised via posters and on the NMIT website.

Students receiving a Hardship grant/scholarship have the option of limited in any NMIT promotions.

Criteria

- A New Zealand resident of Maori descent.
- Exhibit high motivation and the ability to succeed.
- Demonstrate the need for financial assistance that may prevent their ability to succeed.

Panel: The panel will be made up of an NMIT Group Manager or representative and two NMIT staff members.

Selection will be made at a time that allows the scholarship to be awarded early in the academic year.

Timing: Applications must be received on an official application form to NMIT by 2pm on 22 February 2012. Late applications will not be accepted.

Validation: The award of a Scholarship shall become void within 2 weeks after receiving official advice unless the recipient completes and forwards the Acceptance and Agreement Contract to NMIT Scholarship Coordinator that states:

- The Recipients acceptance of the Scholarship and agreement to perform any obligations, as stated in the Terms of Reference. Associated with this Scholarship.
- The Recipients intention of pursuing the course of intended study set out in his/her application.

Payment : This Scholarship is a rebate on fees and will be paid onto students fees account or to studylink if a debt exists

Studylink Notes: Permanent residents and Australian citizens will now be subject to a two year stand down before they can access student loans via Studylink. For more information please contact www.studylink.govt.nz

Privacy: The award of the scholarship may be acknowledged in the local newspapers, website, posters and advertising.
