

NMIT – Te Pūkenga

Te Hāpai Hāpori Pathway's Scholarship

Aim of the Scholarship:

Applicants must have successfully completed the Certificate in Study & Career Preparation (Health) at NMIT and be fully enrolled on either the Paetahi Tumu Kōrero Bachelor of Counselling or the Bachelor of Social Work commencing in 2023.

Value: A one-off payment of up to \$1000.00 towards course-related costs and equipment.

Application due date: 5.00 pm – 19 December 2022

Selection Criteria:

- You must be a New Zealand citizen or permanent resident.
- Supply two references – see scholarship conditions for more information
- A statement of approx. 300 words – see scholarship conditions for more information.
- The applicant may be required to attend a scholarship panel interview.
- Scholarships can only be taken up on the year allocated on the scholarship conditions unless approved by an NMIT Scholarships Delegate.
- All scholarships are available to students at any NMIT Campus, providing the associated programme is offered there.
- Scholarships are for full-time students unless otherwise stated.
- Unless otherwise stated, students must be studying directly with NMIT. Programmes offered through partnerships and subcontracting arrangements are not eligible.

What do you receive?

The scholarship is a one-off payment towards course related costs and equipment to the maximum value of \$3,000.

What do you need to commit to?

- Be available to attend the Scholarship Presentation Ceremony in 2023.
- Be available for Scholarship promotional purposes if required.

Terms and Conditions:

1. If the applicant changes to part-time or withdraws, the scholarship may need to be repaid, and this will be at the discretion of NMIT. You must advise scholarships@nmit.ac.nz of any change of circumstances.
2. The Scholarship may not be awarded in any given year if the calibre of the applicants does not meet the required standards.
3. The scholarship award decision will be made by a panel that includes representatives from the Programme Area and NMIT. Decisions of the Panel are final and are not open to appeal.
4. An application must be completed online via the NMIT website application form and received by NMIT by 5pm, 19th December 2022. Late applications will not be accepted.
5. The student must have commenced study with NMIT and payment of the course made within the NMIT Guidelines, not relying solely on the outcome of the Scholarship.
6. The award of a scholarship shall become void within two weeks after receiving official advice, unless you complete and forward the acceptance and agreement contract to scholarships@nmit.ac.nz that clarifies your acceptance of the scholarship and agreement to perform any obligation, as stated in the terms of reference associated with this scholarship.
7. The award of the scholarship may be acknowledged in media and marketing material by NMIT.
8. In accordance with the Privacy Act 1993, you will need to sign a release form giving your permission for NMIT to use your personal information for publicity in relation to the scholarship.
