#### Selection criteria:


- Must be a New Zealand citizen or permanent resident and member of the Ngāti Kuia Iwi.

### **Terms & Conditions**

- 1. The scholarship may not be awarded in any given year if the calibre of the applicants does not meet the required standards, even if this decision is made after the application date for the scholarship has passed.
- 2. Applications must be completed online via the NMIT | Te Pūkenga website and received by the application due date. <u>Late applications will not be accepted.</u>
- 3. This scholarship cannot be taken in conjunction with any other NMIT | Te Pūkenga scholarship.
- 4. The scholarship does not cover student association fees, re-sit costs or repeat course costs.
- 5. The student must have commenced study with NMIT | Te Pūkenga and payment of the programme of study has been made within the NMIT | Te Pūkenga Guidelines, not relying solely on the outcome of the scholarship being awarded.
- 6. If you withdraw, or do not complete course requirements, the scholarship may need to be repaid. This will be at the discretion of Ngāti Kuia and NMIT | Te Pūkenga.
