



NMIT Scholarship 2026 Zonta Club of Marlborough Scholarship Applicant Terms of Reference

Value:

Scholarship 1: \$1,000 to firstly be applied to course fees, with the balance paid direct to the recipient for current female returning to the workforce.

Scholarship 2: \$1,000 to firstly be applied to course fees, with the balance paid direct to the recipient for current female enrolled in a Level 6 study programme.

Application due date:

Sunday 15 March 2026 midnight

Selection criteria:

- 1. Must be a New Zealand citizen or permanent resident.
- 2. Must identify as female and be currently enrolled in a NMIT full-time Programme or career-related part-time Programme at Marlborough Campus.
- 3. Applicants must be a fees paying female (i.e. not receiving Fees Free during intended year of Scholarship acceptance).

What you need to provide:

Applicants must demonstrate the potential to succeed in their studies with NMIT by providing the required documentation during the application process:

- A statement of approximately 200 words describing their chosen study, future career plans, and explain their goals for the future.
- Two written character/work references
- A copy of their Academic Transcripts from previous years.

What do you receive:

The scholarship is a one-off payment up to the \$1,000.00 towards course fees.

What do you need to commit to:

- May need to attend a scholarship panel interview if required.
- The recipient would be expected to attend the scholarship awards ceremony in Nelson or Marlborough.
- Agree to be available for promotional purposes by Zonta Club of Marlborough or NMIT as per your Media Consent Form.





Terms and conditions:

- The scholarship may not be awarded in any given year if the calibre of the applicants does not meet the required standards, even if this decision is made after the application date for the scholarship has passed.
- 2. Applications must be completed online via NMIT's website and received by the application due date. <u>Late applications will not be accepted.</u>
- 3. This scholarship cannot be taken in conjunction with any other NMIT scholarship.
- 4. The scholarship does not cover student association fees, re sit costs or repeat course costs.
- 5. The recipient must have commenced study with NMIT and payment of the programme of study has been made within the NMIT Guidelines, not relying solely on the outcome of the scholarship being awarded.
- 6. If the recipient withdraws, or does not complete course requirements, the scholarship may need to be repaid. This will be at the discretion of Zonta Club of Marlborough and NMIT.
- 7. The recipient must advise scholarships@nmit.ac.nz of any change to their circumstances relating to their study with NMIT.
- 8. The scholarship award decision will be made by Zonta Club of Marlborough.
- 9. Upon being awarded the scholarship the recipient must complete and forward the **Acceptance Agreement** and the **Media Consent Form** to <u>scholarships@nmit.ac.nz</u>. This initiates their acceptance of the scholarship and indicates their agreement to perform any obligations, as stated in the Terms of Reference associated with this scholarship.
- 10. In accordance with the Privacy Act 2020, the recipient will need to sign a Media Consent Form giving permission for NMIT and Zonta Club of Marlborough to use their personal information for publicity in relation to the scholarship. The recipient can control the content and the length of time it is used.
- 11. Zonta Club of Marlborough and NMIT will promote the Zonta Scholarship recipients in appropriate media in Te Tauihu and throughout New Zealand and within NMIT marketing material which includes brochures, website, and display materials.
- 12. The award of a scholarship shall become void after two weeks if the **Acceptance Agreement** and the **Media Consent Form** are not completed and forwarded to scholarships@nmit.ac.nz.
- 13. The scholarship winner will be announced in the academic year and awarded at the scholarship ceremony which you would be expected to attend.
- 14. The agreed scholarship amount will be paid to StudyLink or to NMIT towards course fees. If the recipient has paid their fees themselves, the scholarship amount will be deposited into a nominated bank account.

StudyLink notes:
