

## Code Purple Culinary Arts Scholarship

**Value:** \$ discretionary to funds raised in previous years by Level 5 students

**Aim of the Scholarship:** To support all students who are looking to enhance their culinary pathways either at NMIT (i.e. culinary competitions, equipment or hardship support)

- To also be offered to Nelson/Tasman School Secondary Hospitality teachers to highlight up and coming student in the culinary fields. This is in the spirit of Catharine Dunkley who would support all students in all aspects of their learning journey

**Applications due date:** 5 pm, 20 February 2020.

### Selection Criteria:

- Applicants must be enrolled on the Certificate in Culinary Arts Level 4 or Trades Academy.
- Applicants must demonstrate the potential to succeed in their studies by providing the following:
  - Character/work references.
  - A short statement (not more than 500 words) stating their future career plans within the Hospitality Industry.
- Applicants must be a New Zealand citizen or be legally able to work and reside in New Zealand. The recipients to commit to:
  - A report to NMIT on their learning and experiences by the end of their scholarship year.
  - Attending the NMIT sponsored Scholarship presentation.

**What do you receive?** Monetary assistance against your application.

### Terms and Conditions:

- If the applicant changes to part-time, withdraws, or does not complete course requirements to continue onto the following year of study the scholarship may need to be refunded, this will be at the discretion of NMIT.
- The Scholarship may not be awarded in any given year if the calibre of the applicants does not meet the required standards.
- This Scholarship cannot be taken in conjunction with any other NMIT scholarship.
- The decision about awarding the scholarship will be made by a panel which includes relevant course representatives from NMIT and lead students from the fundraising year. Decisions of the panel are final and are not open to appeal.
- An application must be forwarded on an official online application form and received by NMIT by 5 pm on 20 February 2020. Late applications will not be accepted. The scholarship will be announced early in the academic year.
- The award of a scholarship shall become void within two weeks after receiving official advice, unless you complete and forward the acceptance and agreement contract to NMIT Scholarships Co-ordinator that clarifies your acceptance of the scholarship and agreement to perform any obligation, as stated in the terms of reference associated with this scholarship.
- The award of the scholarship may be acknowledged in media and marketing material by NMIT.
- The scholarship does not cover student association fees and re-sit costs.
- In accordance with the Privacy Act 1993, you will need to sign a release form giving your permission for NMIT to use your personal information for publicity in relation to the scholarship. You can control the content and the length of time it is used.
