

# Toss Woollaston Scholarship Terms of Reference

Value: \$1000.00

## Aim of the Scholarship:

To support students studying art and design full-time at NMIT who show the potential to make a significant contribution to the New Zealand art scene.

Application due date: 5.00pm – 12<sup>th</sup> of February 2021

## Selection criteria:

- You must be a New Zealand citizen or permanent resident
- Enrolled on a full-time art and design programme at NMIT.
  - Two Character references
  - A statement of approx. 500 words demonstrating the need for financial assistance and show you have the potential to become an ambassador for Creative Industries.
- The applicant may also need to attend a Scholarship panel interview if required.

## What do you receive?

- The scholarship is a one-off payment towards course fees to the maximum value of \$1,000k

## What do you need to commit to?

- Must attend the Scholarship Presentation Ceremony in 2021 at the Nelson Campus
- Agreeing to be available for promotional purposes by NMIT and the Woollaston family.



## Terms & Conditions

1. The scholarship may not be awarded in any given year if the calibre of the applicants does not meet the required standards, even if this decision is made after the application date for the scholarships has passed.
2. The scholarship does not cover student association fees, resit costs, or text books and any other course materials unless as stipulated above.
3. If you change to part-time study, withdraw, or do not complete course requirements, the scholarship may need to be repaid. This will be at the discretion of the Woollaston family and NMIT. You must advise [scholarships@nmit.ac.nz](mailto:scholarships@nmit.ac.nz) of your change of circumstances.
4. This scholarship cannot be taken in conjunction with any other NMIT scholarship.
5. The student must have commenced study with NMIT and payment of the Programme of study has been made within the NMIT Guidelines, not relying solely on the outcome of the Scholarship being awarded.
6. The scholarship award decision will be made by a panel which includes representatives from the Woollaston family, the Programme Area and NMIT. Decisions of the Panel are final and are not open to appeal.
7. Applications must be completed online via the NMIT website and received by [5.00 pm on 12<sup>th</sup> February 2021](#). The scholarships will be announced early in the academic year and awarded at the Scholarship Ceremony which you must attend.
8. The award of a scholarship shall become void within two weeks of receiving official advice unless you complete and forward the Acceptance and Agreement Contract to [scholarships@nmit.ac.nz](mailto:scholarships@nmit.ac.nz) that clarifies your acceptance of the scholarship and agreement to perform any obligations, as stated in the Terms of Reference associated with this scholarship.
9. If a debt exists to Studylink or NMIT it will be paid to these accounts. If no debt exists it will be paid into your nominated bank account.

10. The Woollaston family and NMIT will promote the Toss Woollaston Scholarship recipients in appropriate media and within NMIT marketing material which includes brochures, website and display materials.
11. In accordance with the Privacy Act 1993, you will need to sign a Release Form giving your permission for NMIT and Woollaston Family to use your personal information for publicity in relation to the scholarship. You can control the content and the length of time it is used.
